

Tutoring Services Agreement

This Tutoring Services Agreement is entered into between Double A Academy, and the client collectively referred to as the "Parties."

1. Tutoring Services

1. Description: Double A Academy agrees to provide tutoring services to the Client as described in the tutoring program agreed upon by both Parties.
2. Location: The tutoring sessions will take place at the location mutually agreed upon by both Parties, which may include the Client's home, a library, another suitable location or via online services.

2. Safety and Working Environment

1. Client Responsibility: In the event that tutoring sessions take place at the Client's home, the Client shall ensure the provision of a safe working environment for Double A Academy's tutors. This includes maintaining a clean, safe, and quiet area conducive to learning, free from distractions or hazards that may hinder the effectiveness of the tutoring sessions.
2. Liability Disclaimer: The Parties acknowledge that tutoring sessions may involve various learning activities and exercises. While Double A Academy will take reasonable precautions to ensure the safety and well-being of the Client during the sessions, the Client agrees to assume all responsibility and liability for any injuries, damages, or losses that may occur during the tutoring sessions, whether they are conducted at the Client's home, a library, or any other agreed-upon location.
3. Indemnification: The Client agrees to indemnify and hold harmless Double A Academy, including its tutors and representatives, from any claims, liabilities, damages, expenses, or losses arising out of or in connection with the tutoring services, except in cases of gross negligence or intentional misconduct on the part of Double A Academy.

3. Scheduling and Cancellation

1. Lesson Scheduling: The Parties will agree upon a mutually convenient schedule for the tutoring sessions.
2. Cancellation by Client: The Client agrees to provide a minimum notice of 12 hours for any cancellation or rescheduling of a tutoring session. Failure to provide sufficient notice will result in the Client being charged for the missed session. Exemptions may be made under reasonable circumstances.

4. Payment Terms

1. Fee: The Client agrees to pay Double A Academy the agreed-upon fee for the tutoring services rendered. The payment terms and schedule shall be specified separately in an invoice or payment agreement.
2. Method of Payment: Payments shall be made by the Client through bank transfer or any other mutually agreed-upon method. An invoice will be issued at the end of each week outlining the tutoring services provided and the corresponding fee.
3. Payment Schedule: The Client agrees to make payment within 7 days from the date of the invoice.
4. Refunds: In the event that the Client decides to terminate the tutoring services prior to the completion of the agreed-upon tutoring program, no refunds will be provided for sessions that have already taken place.

5. Term and Termination

1. Term: This Agreement shall commence on the date of the first lesson and continue until terminated by either Party as outlined below.
2. Termination: Either Party may terminate this Agreement by providing written notice to the other Party. Any outstanding fees or obligations incurred prior to the termination shall remain valid and payable.

6. Confidentiality

1. Confidentiality Obligations: The Parties agree to maintain the confidentiality of any proprietary or confidential information shared during the course of the tutoring sessions.
2. Non-Disclosure: The Client shall not disclose or use any confidential information obtained from Double A Academy for any purpose other than the agreed-upon tutoring services. Any material provided to the client is intellectual property of Double A Academy and should not be sold.

7. Entire Agreement

1. This Agreement represents the entire understanding between the Parties and supersedes any prior agreements or understandings, whether written or oral, relating to the subject matter hereof.

Each Party acknowledges that they have read, understood, and voluntarily agreed to be bound by the terms and conditions of this Tutoring Services Agreement.
